- Hostel admission fee is non-refundable.

General Rules for Hostler

1. Hostel accommodation is provided for full academic session and if due to any reason the boarder leaves the hostel the fees once deposited will not be refunded or adjusted.
2. Boarder is advised not to keep excess cash and valuables in the hostel. In case of any loss or damage, the college will not be responsible for it. They may open an account with Indian Overseas Bank in the College premises.
3. Boarder is provided with a chair, a table and a hard bed in the room. In case of any damage to the furniture, the boarder will be responsible. The furniture is not to be shifted from one room to another or outside.
4. Misuse of electricity by using electrical gadgets like irons, heaters, audio players, immersion rod etc. is not allowed. Disciplinary action will be taken against the defaulters.
5. Boarder should submit medical fitness certificate at the time of admission. If any boarder is undergoing any particular treatment, the detailed record must also be submitted at the time of admission.
6. In case of falling sick or any sort of infections, diseases or personal injury, the boarder will inform the hostel authorities and his/ her parents immediately. He/She will pay the expenditure incurred by the college or hostel authority on his/ her treatment.
7. Parents, guests and friends are not allowed to stay overnight.
8. No boarder can leave the hostel without the written permission of the warden after or before college hours. The defaulter will be subject to disciplinary action.
9. Parents/ Guardians should give the details of the visitors (name, relation, Photograph address & Phone number):
 - (a) who can visit the boarder in the hostel.
 - (b) who can take boarder for outing
10. Every boarder must provide the address and phone number of his/ her local guardians.
11. Visitors timings are subject to change during summer & Winter.
12. Parents / Guardians should give written permission if their ward wants to take tuition outside college premises.
13. The visitor must give his/ her detail on the visitor's register before and after taking the boarder for outing .
14. No boarder will be allowed to leave hostel before the autumn or winter break. They must return a day before the college reopens after the vacations. Defaulters will be fined.
15. Boarder will be fined Rs. 100/- per day if he/she fails to join the college after the exhaustion of a sanctioned leave.
16. The Principal, members of Hostel Committee have full authority for the inspection of the rooms bags, almirahs or anyother personal belongings of boarder at any time during day and/ or night in his/ her presence.
17. Boarders are not allowed to hold any meetings and celebrations without the written permission of the warden.
18. Ragging is strictly banned. Boarder must maintain perfect discipline in the hostel and observe the rules of the hostel.
